"Prospects of the economic relationships with the broader Middle East" was the topic of the keynote speech delivered by Michael Glos. After briefly referring to NUMOV's long tradition of promoting relations between Germany and the Middle East he emphasized the growing importance of the region as a trading partner. He said that he has been fascinated with the region and its culture since his early youth and is quite familiar with many of its countries through his official and private visits. He also referred to the region's abundant oil and gas reserves and the huge and growing export revenues of these countries.

Emirates and Qatar. "There are many large interesting projects under way or planned in these countries, such as industrial plants, hospitals, hotels, power stations as well as roads and railways", Glos said.

In his speech, he also welcomed the recent recommendations of the North Africa Middle East Initiative of The German Industry (NMI) to the new Federal German Government and assured his full support for these recommendations.

Glos underlined the importance of expanding economic tools in dealing with foreign markets, such as providing Hermes guarantees, further expansion of the existing network of bilateral chambers of commerce throughout the region, and the adoption of a series of bilateral investment treaties with the countries of the region.

He then went on to stress the importance of integrating the

North African and Middle Eastern countries into the global economy. The WTO entrance of many of the countries of the region is also another important step in this direction, Glos said. He was optimistic about the long-awaited agreement between the EU and the Gulf Cooperation Council and he expressed hope that the treaty would come to a conclusion in the course of 2006.
